The law requires clinics to post their starting charges, expected payment rate from Medicare and Medicaid, and average amount paid by commercial insurance companies.
- The amounts posted do not reflect the amount individual patients or their health insurance plan will owe for the services listed. For specific information about the amount you will owe for the services you receive, please contact your insurer.
- Charges represent the standard amount Ridgeview Rural Health Clinics bills for any service. Most often, charges are not the amount the clinic actually gets paid for the service. For most patients, clinics are paid at a level well below these charges.
- Patients covered by commercial insurance companies have rates specific to their particular company and policy that the insurer negotiated with in-network clinics. These policy-specific negotiated rates are not reflected in these posted amounts. For specific information about the amount you will owe for the services you receive, please contact your insurer.
- Rural health clinics are paid an all-inclusive rate from Medicare and Medicare Advantage for medically-necessary evaluation and management visits. The all-inclusive rate is subject to a maximum payment per visit that is established by congress and updated annually based on the percentage change in the Medicare Economic Index and subject to annual reconciliation.
- Medicaid reimbursement to rural health clinics is based upon a predetermined fixed amount.
- When patients want to shop for medical services, they should contact their own insurance company to get information about which costs will be covered by the insurance company and which will be the patient's responsibility.
