- The amounts posted do not reflect the amount individual patients or their health insurance plan will owe for the services listed. For specific information about the amount you will owe for the services you receive, please contact your insurer.
- Charges represent the standard amount Ridgeview bills for any service. Most often, charges are not the amount the clinic actually gets paid for the service. For most patients, clinics are paid at a level well below these charges.
- Patients covered by commercial insurance companies or Medicare Advantage plans have rates specific to their particular company and policy that the insurer negotiated with in-network clinics. These policy-specific negotiated rates are not reflected in these posted amounts. For specific information about the amount you will owe for the services you receive, please contact your insurer.
- Patients with government-sponsored health coverage, such as Medicare or Medicaid, have clinic payment rates based on fee schedules. The rates listed here do not reflect the amount individual Medicare or Medicaid patients owe for the services. Please contact your insurance program by calling the customer service number on your insurance card.
- When patients want to shop for medical services, they should contact their own insurance company to get information about which costs will be covered by the insurance company and which will be the patient's responsibility.
